CONTROLLED SUBSTANCES ACT 1984 (SA)

CURRENT SECTION 57 ORDERS

The Minister responsible for the *Controlled Substances Act 1984*, under the provisions of subsection 1 of Section 57 of the Act, has the power to issue an Order on a person. This Order in effect withdraws the privileges granted to certain health professionals which enabled them to handle prescription drugs whilst acting in the normal course of their profession. The following is a list of the names of persons who are <u>currently</u> subject of a Section 57 Prohibition Order (or corresponding action under the revoked Narcotics and Psychotropic Drugs Act).

The Order covers the prohibition on the possession, supply, prescribing and administration for Drugs of Dependence (DD) unless otherwise indicated.
